REPORTS GIVEN AT THE PICNIC: Rich Caruso (HOA President) and Ken Tamblyn (SID 176 Chairman). Rich opened his comments with a reminder that the Sarpy County Sheriff's Office will do a house check when a resident is gone for vacation. The resident contacts the Sheriff's Office to make this arrangement. Use the website aaps.sarpy.com and follow the link "Request Vacation Watch." The remainder of his report duplicates information from the HOA Board Meeting and will be included in that article. He concluded by thanking the SID for overseeing the recent street overlay. Ken noted that Larry Brown and Joe Demro (SID Board members) were also present. He discussed the ongoing conversation/negotiation related to possible Gretna annexation of Lake Ridge. No one appears to be taking action at this time. Therefore, the SID determined that it would be best to proceed with the

overlay of the streets in Lake Ridge. The SID had been saving money to accomplish this task and if they waited until Gretna annexed the area the money might not have been used for the purpose of street overlay. The SID was able to restructure its bond debt to a lower rate and save additional money. Ken did

further reported that the work on the lift station has been completed after 2 ½ years. And, a new gas generator has been installed in case of loss of power. Our SID was able to join with those from Pebblebrook, Tiburon South and Tiburon West, which saved significant monies for our SID.

A question was raised about the property at the intersection of 168 th Street and Highway 370. This property has been sold and construction of storage units will begin shortly. These will be one-story units with appropriate landscaping. There will not be any outdoor storage of such items as boats and mobile omes. The Sarpy County Board has determined that there will be just one access off of 168 th Street.

It will be right turn in and right turn out only. Members of our SID Board attended the hearing and there were no objections from Lake Ridge neighbors. Ken noted that this would have a positive impact on our tax base.

It was stated that SID 176 tax rates have not increased over the past five years. The SID Board recently approved retaining the SID mill levy at 25 cents for general purpose and 52.5 cents for the bond fund. He reminded all that this is **just the SID rate**. Tom Demro (SID) stated that it was unusual for an SID to maintain a stable mill levy for five years.

Ken thanked the HOA for the new street signs and indicated that the SID had also had new stop signs installed.

Board President Rich Caruso chaired the meeting with six additional board members present. The 2018 HOA Budget and Balance Statements were reviewed. The Lake Ridge HOA has a current balance of \$16,058.69. The proposed 2019 budget was also discussed. A cover letter will be sent with the next dues invoice explaining how the dues money was spent last year also with a proposed spending plan for 2019.

A question related to the covenants was presented. This relates to the installation of solar panels. At the
